### 1. Divorce by mutual consent is the principle.

Without the agreement of your spouse, you generally cannot divorce.

### 2. But don't give up.

### 1. Not just child support.

Before divorce, you can also claim living expenses (marriage expenses). Marriage expenses need to be filed for immediately. To make monetary payments such as marriage expenses and child support effective, they need to be decided through mediation or recorded in a notarized document. This way, assets and wages can be seized immediately.

## 2. Gaining custody

Custody is determined by affinity (the child's attachment) and eligibility (having suitable conditions for raising children). However, in reality, the parent who takes the children with them has an overwhelming advantage.

# 3. You can meet your children even without custody

Through mediation or trial, you can meet your children once or twice a month. For the children's sake, this level of contact is better. Even if you failed as a couple, cooperation as parents is essential. Therefore, it's necessary to divorce without letting the situation become too messy.
